Effective May 1, 2022:

Burial and Deed Pricing

Section 1. The price of plots for burial shall be determined by the Trustees of the Cemetery and may be adjusted from time to time. The Cemetery shall reserve the right of use of a burial plot to a grantee by issuing a cemetery deed. The price of the deed shall be **\$400.⁰⁰** per plot.

Section 2. Price for full body burials.

- a) Member burial price shall be the total of **\$1,375.⁰⁰**.
Price includes the fee for the maintenance of the plot, and the fee for “opening and closing” the grave as detailed in **Section 5**. Penalty fees may also apply.
- b) Non-member burial price shall be the total of **\$1,775.⁰⁰**.
Price includes the cost of the plot, the fee for the maintenance of the plot, and the fee for “opening and closing” the grave as detailed in **Section 5**. Penalty fees may also apply.
- c) Pricing for Infant burial in a designated infant burial plot shall be the total of **\$650.⁰⁰**.
Price includes the cost of a quarter plot, the fee for the maintenance of the plot, and the fee for “opening and closing” the grave as detailed in **Section 5**. Penalty fees may also apply.
- d) Pricing for Infant burial in a vacant plot shall be the total of **\$950.⁰⁰**.
Price includes the cost of the plot, the fee for the maintenance of the plot, and the fee for “opening and closing” the grave as detailed in **Section 5**. Penalty fees may also apply.

Section 3. Prices for the burial of cremains.

- a) The price to bury cremains in an occupied family member’s plot shall be **\$500.⁰⁰**.
Price includes the fee for the maintenance of the plot, and the fee for “opening and closing” a small cremains grave as detailed in **Section 5**. Penalty fees may also apply.
- b) The price to bury cremains in a vacant plot shall be the total of **\$900.⁰⁰**.
Price includes the cost of the plot, the fee for the maintenance of the plot, and the fee for “opening and closing” a small cremains grave as detailed in **Section 5**. Penalty fees may also apply.

Section 4. The Cemetery does not provide a casket or a vault, nor is it responsible for any expenses incurred to inter a body or cremains, or expenses which are incurred to perform a funeral service. The Cemetery will contact those contractors and vendors who do supply those services, on behalf of the funeral director and at the expense of the funeral director. Payment by the funeral director, to the cemetery, is due at the completion of the burial ceremony.

Section 5. Contractor Pricing Schedules:

1. Harris Burial Services.

Effective February 1, 2022, the fee for “opening and closing” a grave is as follows:

	<u>Monday - Saturday</u>
Regular Adult Graves (full body)	\$725.00
Oversize Adult Graves (full body)	\$775.00
Infant Graves (2ft to 3ft hole)	\$350.00
Large Cremations (hole size over 12" x 12")	\$300.00
Small Cremations (hole size under 12" x 12")	\$250.00

2. Penalty Fees

A fee of **\$200** will be assessed when:

- Notice for burial is given the day prior to service.
- The burial is scheduled on a Sunday or a holiday. The following holidays apply:
 - New Year’s Day
 - Easter
 - Memorial Day
 - Independence Day
 - Labor Day

No burials on Thanksgiving Day or Christmas Day.

An additional fee of **\$100** will be assessed if the burial/services commences after 3:00 PM, plus an additional fee of **\$50/hour** will be charged for each hour past 4:00 PM.

Grass set-ups are available, upon request, for cremations and infant burials, at no additional charge.
